FPCL Participates at the Fiji Business Excellence Conference 2025

FPCL was honoured to participate in the 2025 Fiji Business Excellence Awards Conference, held on 13th June at the Holiday Inn, Suva. His session highlighted FPCL's strategic investments in smart infrastructure and digital transformation, emphasizing the company's commitment to fostering inclusive growth and resilience in Fiji's maritime sector.

Fiji Ports Coordinates Medical Evacuation from Region's Largest Container Ship

In a remarkable show of coordination and maritime responsibility, FPCL together with key border agencies, the Ministry of Health, Fiji Navy, the Maritime and Safety Authority of Fiji and Neptune Shipping, successfully facilitated a medical evacuation operation for a crew member aboard the CMA CGM BYBLOS, the largest container vessel ever to call at a port in Fiji and the South Pacific region.

The incident unfolded during the CMA CGM BYBLOS' maiden voyage from Shanghai to Chile, with the vessel being only one month into service. FPCL worked swiftly and collaboratively with local authorities, emergency services, and port stakeholders to execute the high-priority medical evacuation. The seamless operation highlights Fiji Ports' strategic readiness and capability in handling complex maritime incidents—even involving ultra-large container vessels.

"This successful medical evacuation is a testament to our crisis response planning and the professionalism of our port team," said Vajira Piyasena, CEO of Fiji Ports. "We are proud to have assisted in safeguarding the life of a seafarer while also supporting a vessel of this magnitude."

The CMA CGM BYBLOS (container/post panamax), operated by global shipping giant CMA CGM, is among the newest additions to the world's ultra-large container fleet, capable of transporting over 8,000 TEUs (Twenty-foot Equivalent Units). The ship is also among the new generation of LNG powered ships. Its visit marked a historic moment for Fiji, placing Suva Port on the map as a viable port call even for next-generation cargo vessels.

The medical evacuation coincides poignantly with global commemorations of the International Day of the Seafarer, observed annually on 25th June. This serves as a reminder of the vital contributions and personal risks faced by maritime professionals.

"Supporting our seafarers goes beyond words—it's about action," said Piyasena. "This event reminds us that even the largest ships rely on the health and well-being of every crew member aboard."

The vessel resumed its journey toward South America following the successful evacuation, with the affected crew member now receiving the necessary medical care in Fiji. Fiji Ports continues to reaffirm its commitment to ensuring safe, efficient, and responsive port operations, in service not only to trade but to the welfare of those who navigate the oceans that connect us all.





FPCL's Harbour Master for Suva Port, Captain Laisiasa Gonewai, successfully provided pilotage services to the CMA CGM BYBLOS—one of the largest container vessels ever to berth in Fiji. His expertise was instrumental in safely guiding the ultra-large vessel into Suva Port during the emergency medical evacuation operation.

Fiji Ports Strengthens Security Partnership with Fiji Police Force

In April, Fiji Ports Corporation Pte Limited (FPCL) and the Fiji Police Force signed a Memorandum of Understanding (MOU) to further strengthen collaboration in crime prevention and security across Fiji's major ports. The MOU was officially signed at FPCL's Head Office in Walu Bay, Suva by FPCL Acting Chief Executive Officer Mr. Suresh Prasad and the Commissioner of Police Mr. Rusiate Tudravu.

The MOU formalizes a commitment to work together on crime prevention, intelligence gathering and sharing, investigations, prosecutions, and overall security at all major port facilities and any other declared ports under FPCL's management, as outlined in the Sea Ports Management Act 2005. Through this partnership, FPCL and the Fiji Police Force will collaborate on risk management, operational coordination, and compliance activities within the legislative framework. The agreement also paves the way for joint initiatives to deter illegal activities, enhance law enforcement, and explore opportunities for joint training, development, and resource sharing. At FPCL, maintaining safe, secure, and resilient ports is a top priority, and this partnership marks a significant step towards strengthening the safety of Fiji's maritime gateways.

FPCL Participates in the Fiji-Japan Bilateral Workshop on Port and Maritime Transport Technology

FPCL was proud to participate in the Fiji-Japan Bilateral Workshop on Port and Maritime Transport Technology, held on 12th June 2025 at the Holiday Inn, Suva. The workshop was jointly organized by the Ministry of Public Works, Meteorological Services (MPWMST) and Transport of Fiji and Japan's

Ministry of Land, Infrastructure, Transport and Tourism (MLITT).

Representing FPCL, Chief Infrastructure Officer Mr. Tomasi Sauqaqa delivered a presentation highlighting several of FPCL's key development projects. His session highlighted FPCL's ongoing efforts to enhance port infrastructure and support sustainable maritime growth in Fiji.

The workshop brought together senior government officials, maritime industry professionals, and development partners to foster technical collaboration and knowledge exchange between Fiji and Japan. Japanese experts led technical sessions on port planning and operations, maritime safety, disaster resilience, and the application of emerging technologies. The event also provided an opportunity for Fijian stakeholders to share local insights, discuss mutual challenges, and explore innovative approaches to strengthen maritime connectivity and resilience.

As a follow-up to the workshop, participants also had the opportunity to visit Port of Suva on 13th June 2025. Hosted by FPCL in collaboration with Fiji Ports Terminal Limited, the tour offered participants an on-the-ground perspective of port operations, recent infrastructure upgrades, and the potential for integrating advanced port technologies. The visit also facilitated constructive dialogue on improving operational efficiency, safety standards, and regional maritime infrastructure resilience.

PROJECT UPDATES

Lautoka Port Yard 4 Upgrade Project

The Lautoka Port Yard 4 Upgrade Project continues to advance with critical infrastructure improvements underway across multiple sections of the site.

These included security upgrades, pedestrian access improvements, electrical infrastructure works, including transformer and MSB block construction, underground services inspection through road excavation, lighting system upgrades, including tower reinforcement and high-voltage cable installation, etc.

These works are part of Fiji Ports' continued investment in infrastructure upgrades to improve operational efficiency, safety, and capacity at Lautoka Port.

Lautoka Port Queen's Wharf Rehabilitation Project Update

Significant progress has been made under the Queen's Wharf Rehabilitation Project, with key structural and reinstatement works advancing across multiple stages:

Reinstatement works completed post-sandblasting. Structural repairs completed, including hydro-demolition, reinforcement, and gunite application, along with fender brace installation and steel section treatments. Stage 3 is fully completed, with GreenTech Shield charging systems now operational. Local Wharf: Stage 1 is 99% complete and Stage 2 is at 50% completion. Ramp demolition and joint repairs are 80% done, with some delays due to concrete supply issues.

Lautoka Port Foreshore Development and Port Master Plan Project Update

The final report for the Lautoka Port Master Plan has been officially submitted by the consultant, marking a key milestone in the Foreshore Development and Port Master Plan Project. This comprehensive plan will guide the future development of Lautoka Port, supporting infrastructure upgrades, operational efficiency, and long-term sustainability.

Lautoka Port Maintenance Dredging Project Update

Dredging works at Lautoka Port have been successfully completed. To verify the volumes dredged, a post-dredging bathymetric survey is scheduled to commence on 17th June 2025 and will run through to 17 July 2025. The survey will provide accurate data to confirm compliance with project specifications and ensure navigational safety standards are met.

Suva Port Shed 3 Pavement Project Update

The pavement design for Suva Port Shed 3 was completed in November 2024. Subsequently, the Final Tender Evaluation Report, along with recommendations, was submitted on 8th May 2025, marking the next step toward project implementation. This upgrade aims to enhance surface durability and support improved cargo handling efficiency at Suva Port.

Port of Suva Dredging

Dredging operations at Walubay and Kings Wharf have been completed, with only a final sweep remaining at both locations. Meanwhile, dredging at Princess Wharf is still pending and scheduled for a later phase of the project. These works are part of ongoing efforts to maintain safe navigation depths and enhance operational efficiency at the Port of Suva.

LEARNING AND PROFESSIONAL DEVELOPMENT

FPCL Advances ISO 27001:2022 Certification Journey with Successful Internal Auditor Training

FPCL's journey to pursuing the ISO 27001:2022 Information Security Management System (ISMS) certification (covering information security, cybersecurity, and data protection) continues with successful completion

of a 2-day training workshop. The training was conducted by an external auditor on 22nd & 23rd May 2025.

The Internal Auditor training was delivered to twelve (12) FPCL participants from various departments chosen as internal auditors of the ISMS. The training provided participants with in-depth insights into the ISO 27001:2022 framework, internal auditing techniques, and the practical application of security controls in an organizational setting. As FPCL continues its structured journey toward ISO 27001:2022 certification, the organization remains committed to fostering a culture of continuous improvement and information security excellence.

UPDATES FROM FSHIL

FSHIL Slipway Rehabilitation Project

Progress continues on the FSHIL Slipway Rehabilitation Project, with significant milestones reached in the development of the 1,000T Slipway:

The chem-setting of horizontal rebars for the center beams and the tying of horizontal rebars for the center beams has been completed. Tying of horizontal rebars on the North beam has commenced, while the bending and cutting of rebars for the South beam has also been completed. Placement of rebars into drilled anchor holes and fabrication of the formwork is in progress. The revised completion date for the 1,000T slipway is set for 28th August 2025.

This project is a critical investment in strengthening FSHIL's infrastructure and expanding its capacity to service larger vessels efficiently and safely.
