## Fiji Ports Pays Out Divided to its Shareholders

Fiji Ports Corporation Limited (FPCL) declared a \$17.05 million dividend for the 2024 financial year, reflecting strong operations, a successful public-private partnership model, and the commitment of its employees.

The dividend was officially presented on 23rd July 2025 at a ceremony attended by the Hon. Prime Minister and Minister for Foreign Affairs, Climate Change and Environment, Civil Service, Information and Public Enterprises, Sitiveni Rabuka, together with the shareholders: Government, Fiji National Provident Fund and Aitken Spence (PLC). Despite global and domestic challenges, FPCL achieved a net profit after tax of \$28.41 million, enabling the dividend payout and a performance-based bonus for staff.

## Fiji Ports Awards 2024 Staff Bonus Following Record Performance

On 31st July 2025, FPCL announced a performance-based bonus payout for all eligible staff, following the company's record-breaking net profit after tax of \$28.41 million for 2024. The Board approved a performance-based bonus payout of \$376,299.70 to 151 staff for the financial year 2024.

Board Chairman Mr. Isikeli Tuituku credited the achievement to strong governance, disciplined operations, and the dedication of FPCL's employees. He also acknowledged past Board members for laying the foundation for success.

The Chief Executive Officer, Mr. Vajira Piyasena highlighted that the company achieved a net profit after tax of \$28.41 million marking the highest milestones in our company's history, enabling a dividend distribution of \$17.05 million to our shareholders. He praised staff across all levels for driving operational excellence and staying committed to FPCL's vision as the Smart, Green Gateway for Trade in the Pacific. The bonus reflects FPCL's appreciation for its staff's hard work and marks the beginning of a new era of transformative growth.

Key takeaways for FPCL included the importance of proactive communication with unions, adopting a collaborative rather than adversarial approach to dispute resolutions, and the need to continuously align company policies with evolving employment laws and best practices. As a next step, FPCL may consider reviewing its current industrial relations framework and exploring training opportunities for line managers to embed these principles to their departments and units.

### A Major Initiative for the Removal of Derelict Vessels Launched

The Waitt Foundation and Waitt Institute of the United States has given Fiji's Joint Marine Environment Committee a 12-month deadline to remove derelict vessels from Suva Harbour. This directive follows the launch of the Jonathan Smith Derelict Vessel Removal Fund, which has been awarded US \$1 million (FJ \$2.25 million) to support immediate cleanup and removal efforts. The funding will directly support the removal of vessels that pose environmental and navigational hazards in the harbour.

FPCL has identified 17 derelict vessels of high priority for removal. The initiative builds on the legacy of the late Captain Jonathan Smith, former master of the traditional Fijian voyaging canoe Uto Ni Yalo, who championed efforts to clean Suva Harbour.

Minister for Transport Ro Filipe Tuisawau confirmed that the Joint Marine Environment Committee will lead the project. The Committee includes representatives from the Ministry of Public Works and Transport, Ministry of Environment and Climate Change, Fiji Ports Corporation Limited, the Maritime Safety Authority of Fiji, and Blue Prosperity Fiji.

# ISO 27001-2022 Information Security Management System – Stage 1 Audit

FPCL continued its journey toward ISO 27001:2022 certification (covering information security, cybersecurity, and data protection) with the successful completion of a 2-day Stage 1 Audit conducted remotely by FPCL's thirdparty audit body, Det Norske Veritas (DNV). The audit concluded successfully with positive outcomes. As FPCL progresses through its structured certification journey, the organization remains committed to fostering a culture of continuous improvement and information security excellence. The certification audit is scheduled for 3rd—7th November 2025.

### **FPCL Undergoes 5S Certification Audit**

On 3rd September 2025, Fiji Ports Corporation Limited (FPCL) undertook its 5S Certification Audit, facilitated by the Fiji National University's (FNU) Department of Quality & Awards. The audit, held at FPCL Headquarters — Muaiwalu House, forms part of the organisation's ongoing commitment to quality and continuous improvement.

The assessment focused on the five core principles of 5S: *Sort, Set in Order, Shine, Standardise, and Sustain*. As part of the process, FPCL staff and 5S Champions were interviewed by the FNU audit team. The auditors recognised the dedication of FPCL's 5S Champions and acknowledged the valuable mentorship provided by Mr. Rajneel Prasad of FNU.

FPCL now awaits the official outcome of the audit, further demonstrating its commitment to workplace excellence and continuous improvement.
